Below are some steps you can take to create an engaging and successful webinar:

- 1. Choose a relevant and exciting topic: The first step is to choose a topic are that interests your audience. Conduct research to identify current trends and issues in your field and select a topic that addresses these.
- 2. Define your target audience: Know your audience is APMAA members worldwide. Design the webinar to meet their needs and create content that resonates with them.
- 3. Create a detailed outline: Create a detailed outline of the webinar content. Use this to structure your presentation and ensure that you cover all the essential points.
- 4. Use engaging visuals: Use high-quality visuals to make your webinar more engaging. This includes slides, images, and videos that are relevant to your content.
- Promote your webinar: Develop flyers, and promote your webinar through various channels, such as social media, email, and online forums. Learn from the flyers of APMAA past webinars (Get them at <u>APMAA</u> <u>Webinars (2021-) (sakura.ne.jp)</u>. Ensure your flyers include information about the date, time, registration process, outline of presenters and presentations, etc.
- 6. Engage your audience: During the webinar, engage your audience by asking questions, soliciting feedback, and encouraging participation. Use interactive tools like polls and surveys to keep your audience.
- 7. Follow up: After the webinar, follow up with your audience to thank them for attending and provide additional resources or materials related to the topic.
