Message From APMAA Chairperson



Dear Colleague, thank you for your support and commitment to the APMAA activities over the years.

We hold the 2022 APMAA annual conference at Dhurakij Pundit University, Bangkok, Thailand, on Hybrid Mode on November 8-11. The conference theme is "Management Accounting: Recent Themes and Directions for a Digital Future." Here, I want to introduce you to the array of events planned for the APMAA 2022 Conference.

Tuesday, November 8, is the day for the 2022 Doctoral Colloquium, with students presenting their research papers. In the afternoon, we plan to have a doctoral seminar. The theme is "Expectations of the doctoral students: supervisors' viewpoints." Seminar panelists are incumbent supervisors who tackle issues and problems that doctoral students face and will provide answers based on their rich experiences.

On Wednesday, November 9 (Day 2), we will have a plenary session of the conference, with three talks by prominent Thai professors. We allocate the afternoon of November 9 and the entire day of Thursday, November 10 (Day 3) to Academic Paper Sessions. We will assign between two to three papers to each Academic Paper Session. Each paper is given a total of 35 minutes: 20 minutes for presentation, 10 minutes for discussion, and 5 minutes for Q & A.

On the afternoon of November 10, we provide two forums. The first Forum discusses the topic, "Accounting Research: Growing Our Impact," inviting two prominent accounting scholars, Prof. Dr. Thomas Ahrens and Prof. Dr. Fumiko Takeda, who have committed to APMAA for years. They discuss the roles of accounting research in the academic community and society. Prof. Dr. Kanibhatti Nitirojntanad, Chulalongkorn University, moderates the Forum. Prof. Normah Omar (UiTM, Malaysia) moderates the second Forum that addresses the topic "Expectations for APMAA Conferences," inviting chairpersons of past and forthcoming APMAA annual conferences as panelists. Three panelists who have agreed to participate are namely Prof. Mayangsari (Trisakti University), Prof. Tian (Xi'an University), and Prof. Thuy (Vietnam National University).

It is our policy that conference organizers develop programs and schedules that are "of the members," "by the members," and "for the members." I am confident we can deliver a meaningful and well-run conference by following the policy. On November 11 (Day 4), we invite international participants to a one-day bus tour, either for a Culture Visit or a Factory Visit.

About Academic Paper Sessions

We allocated two papers to each Academic Paper Session. Each paper is given a total of 35 minutes: 20 minutes for presentation, 10 minutes for discussion, and 5 minutes for Q & A. Two discussants and one moderator facilitate each session.

We recommend **that presenters prepare 10-20 PPT slides for their 20 minutes** presentations.

Presenters are expected to promptly send the updated version to the moderator and discussant when there is any update in their camera-ready paper.

Each **discussant** will be given a 10 min slot for his/her view/comments. We recommend discussants prepare 7-10 PPT slides to convey their points.

A **moderator** coordinates an assigned session and keeps a copy of the presentation and discussion slides provided by the session presenter and discussants before the Conference Day. Should the discussant be unavailable (e.g., no show-up) on the day, the moderator assumes the discussant role and discusses the papers based on the slides at hand.

Ensure that you are comfortable with your position and can manage the time effectively at APMAA academic paper sessions. We can conduct online meetings and rehearsal sessions to help facilitate your respective roles.

Forum 1: Accounting Research: Growing Our Impact. 14.30-15.30, Thursday 10

Academic accounting research addresses broad topical areas within accounting, using various methodologies and theories. Forum 1 invites two prominent accounting scholars, Prof. Dr. Thomas Ahrens and Prof. Dr. Fumiko Takeda, who have committed to APMAA for years. Prof. Dr. Ahrens frequently uses a qualitative approach and organizational and institutional theories; on the other hand, Prof. Dr. Takeda uses an econometric and marker approach. They discuss the roles of accounting research in the academic community and society also.

Thomas Ahrens is a Professor of Accounting at UAE University and has previously held positions at the LSE and the Universities of Southampton and Warwick. He earned his PhD at the LSE. He has conducted research on accounting and management control practices in companies as well as the institutional functioning of accounting in a variety of public sector contexts. He has also written on methodological questions related to qualitative accounting research. Thomas is currently serving as Editor of *Qualitative Research in Accounting and Management* and Associate Editor of *Management Accounting Research*. For ten years, he was an Associate Editor of *Contemporary Accounting Research*.

【Message from Prof. Dr. Ahrens】 My talk is entitled "Writing Vocational Research Papers." It addresses two questions: How can we write inspired research papers? And what responsibility has the researcher for the effects that the research paper may have, both, in the academy and society more broadly? The talk uses Max Weber's idea of science as a vocation and suggests some alternative approaches to contemporary vocational research paper writing. Some examples of such papers are given. I will speculate about forces that can enhance the vocational character of research and research papers.

Prof. Dr. **Fumiko Takeda**, Keio University, Japan



F. Takeda received her Ph.D. in Economics from Yale University. She joined the faculty of Keio Business School in 2022, following eighteen years at the University of Tokyo and two years at Yokohama City University. Prior to joining academics, she worked as Economist at Nomura Research Institute, Ltd. Takeda's work can be found in the *Journal of Accounting, Auditing & Finance*, the *International Journal of Accounting*, and *Pacific-Basin Finance Journal*, among others. Takeda sits on the editorial board of the *International Journal of Accounting* and serves as Associate Editor for the *Japanese Accounting Review* and *Electronic Commerce Research and Applications*. The teams try to notify the corresponding author of the result as soon as possible to help authors arrange their conference registration and participation. It is your responsibility to ensure that your submission satisfies the formatting requirements below.

Formatting Requirements

All manuscripts should be in Times New Roman, font size 12, double-spaced with an abstract of 200-300 words. Include up to 5 keywords. An abstract should be on a separate page immediately preceding the text.

Manuscripts should be as concise as the subject and research method permit. The length of text should be over 5,000 but not exceed 10,000 words.

All papers will be double blind reviewed. To promote anonymous review, authors should not identify themselves directly or indirectly in their paper. Single authors should not use the editorial "we." Referencing should follow the APA style (Refer to <http://www.apastyle.org>).

The cover page should contain the title of the paper (all bold capitals), the author's name (first name, initial (s), and family name), title and affiliation, phone numbers, and email address.

Notification of Paper Acceptance: The APMAA 2022 conference organizing committee (Asst. Prof. Dr. Siridech Kumsuprom, Academic Paper Session Chair) will send you the paper review results before September 1. The committee, however, notifies you of the review result as soon as possible to help you prepare for the APMAA 2022 Conference. If you submit your paper to the doctoral Colloquium, paper review results will be sent to you by Asst. Prof. Dr. Leela Tiangsoongnern in early August.

Proceedings (camera-ready) Paper and PPT: If your paper is accepted, you must prepare and submit a *proceedings (camera-ready) paper* to your CMT account by *September 15*. Please complete your membership and participation fee payment by the date. In addition, you must submit your PowerPoint file to your CMT account by October 15. After confirming your proceedings paper submission and fee payment completion, you are included in the APMAA 2022 program book and presentation schedule.

Registration and Attendance: At least one of the authors should register (pay the participation fee) for the conference *before September 15* and attend as well as present the paper at the conference. *Note that your registration will not be complete until you pay the membership and conference fees.*

Letter of Invitation: Please request either Academic Paper Session Chair or Doctoral Colloquium Chair to issue a Letter of Invitation if the document is required for you to apply for subsidies and/or a tourist visa after submitting your proceedings paper to the CMT.

You can apply for the "tourist visa" directly at the Thai Embassy / Consulate nearby. Citizens of the countries having visa exemption arrangements with Thai can arrive in Thailand (Visa on arrival) with their passports without going through any procedure in advance.
