# Panel of Experts



## Prof. Emeritus Dr. Susumu Ueno

Chair of the Board of Directors, APMAA  
Professor Emeritus , Konan University, Japan

He is the Chair of the Board of Directors of the Asia-Pacific Management Accounting Association (APMAA) and Chief Editor of the Asia Pacific Management Accounting Journal. He previously served as APMAA President (2010–2013) and held major leadership roles in the Japanese Association of Management Accounting, including Vice President and Editor-in-Chief. In 2014, he received JAMA’s prestigious Special Award for his exceptional contributions to management accounting research and education. A Professor Emeritus at Konan University, he has authored several influential books and published widely in international journals. He holds an MBA from the University of Maryland and a DBA from Southern Illinois University.



### **Prof. Emeritus Dr. Normah Omar, CMA**

Professor Emeritus, ARI, Universiti Teknologi MARA, Malaysia  
Board of Directors, Asia-Pacific Management Accounting Association

She is the first woman to be conferred the title of Emeritus Professor by UiTM, is a pioneering scholar in Islamic Financial Criminology. She has earned major international awards, including the 2020 Womani Award (1st place) and the 2019 GIFA Lifetime Achievement Award. As Director of the Accounting Research Institute (ARI), she elevated it to a Hi-CoE in Islamic Finance. Widely recognised for her influential research and global consultancy, she has played a key role in positioning Malaysia as a hub for Islamic finance. She continues to mentor numerous academics and contribute actively to advancing the field.



### **Prof. Dr. Shahzad Uddin**

Professor of Accounting, Essex Business School,  
University of Essex, UK

He is a Professor of Accounting at Essex Business School and Director of the Centre for Accountability and Global Development at the University of Essex. He is the founding editor of the Journal of Accounting in Emerging Economies (JAE). In recognition of his pioneering work, he received the British Accounting and Finance Association's Distinguished Academic Award in 2022. His research examines how accounting functions as a social and political practice studying themes such as labour control, governance, sustainability, and development across Asia, Africa, and the Middle East. In 2024, he was awarded Fellowship of the Academy of Social Sciences for his significant contributions to the field.





## **Prof. Dr. Md Shahinul Alam**

Vice Chancellor, Bangladesh Medical University, Dhaka

Professor Dr. Md Shahinul Alam, Vice Chancellor at Bangladesh Medical University, is a distinguished pioneer in Bangladesh for research on Metabolic Associated Fatty Liver Disease (MAFLD/NAFLD). According to Scopus, he is the leading scientist of BMU, with 3447 citations and 182 publications to his credit. Dr. Alam's academic journey includes MBBS, FCPS (Medicine), and MD in Hepatology. His global recognition is reflected in seven international awards, including honors from APASL (2004), AASLD (2008), the USA-Japan Joint Medical Science Award (2009), and travel bursaries in Indonesia, China, and Turkey. Recently, he was appointed as a member of the Global NASH Council, a prestigious USA-based body of leading hepatologists. He serves on the Editorial Board of the World Journal of Hepatology and reviews for leading publishers including Elsevier, Springer, Wiley, and Blackwell. Beyond academia, he represents Bangladesh in the Acute-on-Chronic Liver Failure Research Consortium, contributes to international guidelines, and advocates for patients with Hepatitis B and C against discrimination. He is also the only clinician in Bangladesh researching medical economics, highlighting the financial struggles of middle- and low-income patients.



## **Prof. Dr. Masumi Nakashima**

Professor of Accountancy, Bunkyo Gakuin University, Japan  
Board of Directors, Asia-Pacific Management Accounting Association

Masumi Nakashima is a Professor of Accountancy and Associate Dean of the Graduate School at Bunkyo Gakuin University. She is also an Adjunct Lecturer at Meiji University and serves as an External Co-Supervisor at UniversitiTeknologi Malaysia (UTM). She holds a Ph.D. and an MBA from Nanzan University, Japan. Her research focuses on corporate governance, integrity in disclosure, and forensic accounting. She is the Representative Director of the Association of Forensic Accounting in Japan (AFAJ). In January 2025, she was granted a patent titled “Financial Statement Fraud Estimation Device, Financial Statement Fraud Estimation Method, and Program.” She has received the Grant-in-Aid for Scientific Research (KAKENHI) continuously since 2012 and served as a KAKENHI reviewer in 2017. Her major publications include “Did Japanese-SOX Have an Impact on Earnings Management and Earnings Quality?” in the Managerial Auditing Journal, and “Has the COVID-19 Pandemic Changed Firms’ MD&A Disclosure Approach? Evidence from Japan,” in the Journal of Forensic Accounting Research (2023), making her the first Japanese researcher to publish in this journal.





### **Prof. Dr. Md. Abul Kalam Azad**

Webinar Co-Chair, Pro-Vice Chancellor  
Bangladesh Medical University, Dhaka

He is a Pro-Vice Chancellor (Administration) of Bangladesh Medical University is a distinguished internal medicine specialist and academic leader with extensive contributions to clinical service, postgraduate training, and medical research in Bangladesh. A Fellow of the Royal College of Physicians (Edinburgh & London), he holds an FCPS in Medicine and is a gold medalist for his outstanding academic achievements. His research spans infectious diseases, metabolic disorders, antimicrobial resistance, clinical case studies, and COVID-19 therapeutics, with over 60 publications. His professional interests include advancing internal medicine services and supporting underprivileged patients. He has received notable honors, including the ASHAB Memorial Gold Medal and Prof. Abdur Rahman Memorial Award. UNESCO & Ministry of Education of the People's republic of Bangladesh jointly awarded him Best teacher in Bangladesh in Medical education category in this year.



### **Prof/A Dr. Kanitsorn Terdpaopong, CMA**

Associate Professor, Rangsit University, Thailand  
Board of Directors, APMAA

Dr. Kanitsorn Terdpaopong is an accomplished academic leader and the Director of the Master of Accounting Program at the Faculty of Accountancy, Rangsit University, Thailand. She holds a Ph.D. in Accounting and Finance from the University of New England, Australia, where she previously served as a lecturer, and is a U.S. Certified Management Accountant (CMA).

Her research leadership focuses on Management Accounting, Financial Resilience, ESG, and Digital Transformation. Dr. Kanitsorn has successfully secured and directed numerous competitive research grants from prestigious international bodies, including the IMA Research Foundation (USA), the European Union (SEASAC), and the Australian Government. Her scholarly contributions appear regularly in high-impact Scopus-indexed journals, addressing critical issues such as corporate profitability, ESG disclosures, and financial stability in the post-COVID-19 era. She also currently serves as the Director of the International Conference Sandbox.



### **Prof. Dr. Mosaddak Ahmed Chowdhury**

Professor, Dept of Business Administration  
Shahjalal University of Science and Technology, Sylhet, Bangladesh

He is a distinguished academic and entrepreneur who have been delivering his service as a Professor in the Department of Business Administration at Shahjalal University of Science and Technology in Sylhet, Bangladesh. His research interests encompass strategic marketing management, entrepreneurship development, the Fourth Industrial Revolution, and Small and Medium Enterprises. Dr. Chowdhury published research articles in national and international journals extensively on topics such as microfinance, SME policy, and the role of information and communication technology in business performance. Beyond academia, he is actively involved in various organizations such as the founder President of the Asia Small Business Federation, Country Director of iTrain Asia, Bangladesh, Chairman of Rescue Aid Trust (UK), Bangladesh.



### **Prof. Dr. Syed Abdul Hamid**

Institute of Health Economics, University of Dhaka, Bangladesh

He is a Professor at the Institute of Health Economics, University of Dhaka, where he also served as Director from 2016 to 2019. He holds a PhD in Economics from the University of Sheffield and an MSc in Health Economics from the University of York. Dr. Hamid has contributed extensively to health economics research, including studies on equity in health, gender inequities, health financing, and health services for Rohingya GBV survivors. His publications include works in the Oxford Encyclopedia of Health Economics and the Journal of International Development. He serves as a member of the Institutional Review Board at IHE and leads multiple funded research projects, such as social health insurance for public servants and the economic burden of dengue in Bangladesh.



## **A/Prof Dr. Farhana Begum**

Dr. Farhana is an accomplished academic, researcher, and leader in the field of accounting and management. She is a Postdoctoral Researcher with the Islamic Development Bank (IsDB) and serves as Associate Professor in Accounting at the DSHE, Ministry of Education, Bangladesh, as well as Director of the Asia-Pacific Management Accounting Association. She holds MPhil and a PhD in Accounting, having earned her doctorate with a prestigious scholarship from the University Grants Commission (UGC) of Bangladesh. She received a research grant from the Institute of Management Accountants (IMA), USA, and a Merit Scholarship for Postdoctoral Research from the Islamic Development Bank (IsDB). In addition, She was honoured with the Woman of the Year 2022 – Most Influential Woman in Islamic Business and Finance award by Cambridge IFA (UK), recognizing her outstanding contributions as a professional, researcher, and author. Dr. Farhana has extensive experience in graduate and postgraduate teaching, as well as supervising research at Jagannath University, Bangladesh, in the Dept. of AIS. She has been actively engaged in scholarly research and has published numerous articles and book chapters. Her work has appeared in leading international journals, including Sustainability, International Journal of Health Planning and Management, Frontiers, Journal of Health, Population and Nutrition, ABDC, Emerald Insight, Wiley, Springer Nature, MDPI, and PLOS ONE etc.
