# APMAA in 2022

Even after two years of the global coronavirus crisis, the pandemic is not controlled. What will APMAA do in 2022? As an association of like-minded researchers and experts in accounting, we will continue to deliver research projects and events that help us serve the accounting research and educational community worldwide. We have set up five teams: the Headquarters' Conference Quality Control Team, the Workshop and Seminar Team, the Research Project Management Team, the Conference Venue Search Team, and the Member Service Team.

On 9 (Wednesday)-11(Friday) November 2022, we will have the 2022 APMAA Annual Conference at Dhurakij Pundit University, Bangkok, Thailand. The conference theme is "Management Accounting: Recent Themes and Directions for a Digital Future." Today, technology is reshaping the digital landscape of the organization and the associated business models.

We find precursors of cyber-physical systems (CPS) in areas as diverse as aerospace, automotive, chemical processes, civil infrastructure, energy, healthcare, manufacturing, transportation, entertainment, and consumer appliances. Data sources for CPS are the Internet of Things (IoT), the Internet of People (IoP), and the Internet of Service (IoS). CPS creates a new world where data collected in the physical world is assessed and analyzed with digital technology and then fed back to the physical world to promote advances and improvement. Exploiting AI, big data, and other cutting-edge digital technology integrated by CPS will allow us to improve automated solutions in the physical world and change our workplaces and the ways we work.

In the accounting area, digital technologies such as big data, cloud, blockchain, and artificial intelligence are possible influences on accounting, auditing compliance practice, and financial procedures. We observe the automation and robotization of routine processes, the introduction of business intelligence, and the application of data analytics. Data scientists and Accountants collect, organize, validate, mine, and analyze data.

Management accountants use data analytics to support value creation, which can be through increasing efficiency, improving profitability and cash flow, but also through customer management, innovation, and intellectual property. Big data can be used to dig out behavioral patterns in consumer and market trends that accountants can use to identify profitable investment opportunities that previously had been missed.

And yet it is the case that data analytic methods can only analyze old data that was thought to be important enough to collect. It cannot create new ideas, nor can it imagine what additional data could be of interest. When the management accountant is sufficiently educated in the analytic

methods then they can use those methods to innovate with new ideas about products or new ideas about what data to gather. The Data Scientist tends to focus on the story the existing data can tell, the management accountant should focus on seeking out the whole story using data analytics as one tool to represent the past as they use insight to look into the future.

Digitalization seems to have disrupted the accounting domain. However, there are still insufficient academic research outputs examining digitalization in accounting and its impact on practices, education, and research. Let's discuss these vital issues together at the 2022 annual conference. We need to change and modify education programs to prepare accounting students for work in a current digitalization environment. We will distribute the 2022 Call for Papers and the APMAA 2022 Conference News in January and February.

APMAA is a "members-first" organization. Under the current competitive environment among academic associations, we are keen to provide quality service to our members. APMAA Annual Conference organizers have allocated sufficient time to each presenter and discussant to present and discuss research manuscripts. It will enable them to discover new viewpoints that become intellectual seeds and expand their insights and understanding of their disciplines.

Our journey to the 20th-anniversary conference has just begun. I am grateful that we can work together towards the strong, sustainable, balanced, and inclusive growth of APMAA. Let's walk the APMAA path hand in hand. Stay safe, stay healthy, and stay connected.

2021 has been a fairly challenging year for APMAA, yet a very exciting one. Zig Ziglar once said, "...when obstacles arise, you change your direction to reach your goal; you do not change your decision to get there..." Like many other organizations, the Covid-19 pandemic has required us to "change our direction." Although the APMAA Conference 2020, which was supposedly be hosted by the Malaysian Team, had to be suspended, we decided that the 2021 conference must go on.

Initially planned to be a hybrid version, it was later changed to a fully online conference by both the Indonesian and the Headquarters' teams. Since this was APMAA's first online annual conference, it was proposed that the Indonesian teams (for Doctoral Colloquium and Annual Conference) must work closely with the head office. A quality control team was formed to ensure that both the conference and the conference papers were of high quality. "Gatekeepers" and paper reviewers were appointed. To be more structured, it was further proposed that Trisakti University should host the annual conference and Udayana University to organize the Doctoral Colloquium.

To facilitate the tasks, the Conference Management Tool (CMT) system was fully utilized and closely monitored. All papers must be submitted and reviewed through the CMT platform. APMAA also held various online meetings to assist the Indonesian teams with their preparations for the APMAA 2021 Conference. The conference was successfully held on 9-11 November 2021.

Both teams from Trisakti and Udayana universities must be commended for their efforts, creativity, and efficiency in handling the 2021 online conference and Doctoral Colloquium. All in all, participants were very impressed; congratulations.

Moving forward, APMAA is preparing for its future conferences, regardless of possible eventualities. New teams have been formed to handle Quality Control, Conference Venue Search, Workshop and Seminar, Research Project Management, and Member Service. APMAA's journal, Asia Pacific Management Accounting Journal (APMAJ), is currently listed in WOS's Emerging Source Citation Index (ESCI), ASEAN Citation Index (ACI), Malaysian Citation Index (MCI) and is being considered for inclusion in SCOPUS. 2021 has also seen the publication of APMAA's research book titled "Management Accounting in China and Southeast Asia" by Springer.


Looking forward to seeing everyone in Bangkok, Thailand, for the APMAA 2022 Conference organized by the Dhurakji Pundit University.
