It must be acknowledged that Covid-19 that started towards the end of 2019 had brought about many challenges and, at the same time, expedited various opportunities that changed the way we perceive and do things. For APMAA, the Pandemic forced the Malaysian team (in consultation with the Head Office) to suspend its APMAA 2020 Conference, scheduled to be held in Shah Alam, Malaysia, in November of that year. In replacement of the annual conference, a series of webinars (carrying the same theme as the conference) were held in October and November 2020. Two sets of webinars (Spring & Summer) continued to be held in 2021 and 2022 as additional activities for APMAA. Since 2020, APMAA conference themes have focused on ICT and the evolution of ICT systems, Digitalization, Disruptive Technology, and New Technologies. Covid-19 has indeed expedited the use of digital technology to support the global Industry 4.0 agenda.

As the Pandemic did not show any sign of regression, the APMAA Conference 2021, cohosted with the Indonesian team, had to be held entirely online. Both Udayana University) and Trisakti University were very creative in using the Zoom Conference application to ensure participants from different global time zones enjoy the annual conference effectively. Cultural events were showcased online, and audiences had the perception that they were there in person. The CMT system helped us to manage the conference papers.

When the Covid-19 Pandemic entered its endemic stage in early 2022, many countries in Asia started to open up their borders. APMAA decided on a hybrid-mode approach for its 2022 annual conference. Many APMAA directors from various parts of the world attended the long-awaited" onsite" version of the conference. I hope we can hold APMAA Conference 2023 entirely onsite. Traditionally, APMAA loyal members love to attend the annual event onsite. The conference programs (i.e., Doctoral Colloquium, Academic Conference, Cultural and Industry visits) have been tailored-made since APMAA's inception in 2004 to fulfill members' needs towards international collaborations.
