## 1. 2021 APMAA Memberships Fee Payment

#### 1.1. APMAA membership and the 2021 annual membership fee

APMAA is an open network. Memberships are in two categories: Membership (Professors, Lecturers, CMA, CPA, Tax accountant, financial analyst, etc.) and Associate Membership (current Doctoral Students). For the calendar year 2021, the annual fee of both the membership and the associate membership is USD 10. This annual membership fee covers the period from January 1 to December 31, 2021. The membership fee is not refundable.



#### **2021 Parallel Sessions Gatekeepers (Paper Review Team Leaders)**

Every year, the APMAA conference is hosted by a different team/country. For quality control purposes, the APMAA has been subscribing the CMT system for several years now. The system allows us to be consistent in our approach of reviewing papers submitted to the conference. It also inculcates the culture of transparency within our association, as all review activities are properly documented in the system and accordingly communicated to the authors within the stipulated time. It is crucial that the paper review process remains consistent. At the APMAA top management level, we want to make sure that participants and paper presenters find real values in attending the APMAA conference. The three-tier paper review process involves: (i) Track Chair checks the suitability of paper to the APMAA's conference theme, (ii) Meta Reviewer checks the overall quality of the paper and assigns the paper to appointed reviewers, (iii) Reviewers assess papers (excluding those from their own country). Authors receive feedback and edit their papers for the conference (August 20, 2021).

It has been an exciting and interesting process being a Gatekeeper and Reviewer for the 2021 Conference. I have read many interesting papers, including papers that are not in my main area, but that have sparked an interest in new areas. As a Gatekeeper in the APMAA tradition, my role is to help papers get accepted by being a good shepherd. This is a special model of research development that we have developed at APMAA. We want to invite you in, not screen you out! This process takes a lot of attention since we also maintain high standards of quality for our papers. We are very lucky that Professor Ueno has set the tone for this process that allows us to include many contributions from across the research spectrum while at the same time encouraging researchers to do their best work.

We will ask the authors of an accepted paper to submit a proper draft of the proceedings paper that enables us to edit the 2021 "Book of Abstracts" and "Proceedings." Attached PDF is the **Instructions for preparing the APMAA** proceedings (camera-ready) paper."

Despite repeated instructions, some authors have not met the APMAA "Guideline of Authors" until today. Probably, they have not read our Homepage and newsletters. APMAA 2022 needs a scheme that leads all authors to follow APMAA guidelines and rules properly.

## **APMAA 2021 Annual Conference and Our Strategic Direction**

Dear Colleague, thank you for your support and commitment to the APMAA activities over the years.

The COVID-19 pandemic has put all academic associations through a rigorous strategic-resilience test, making in-person conferences not possible. As a result, APMAA suspended the 2020 annual conference but connected with our members via a webinar series consisting of eight seminars between October and November 2020. This year, we have additionally completed both Spring and Summer webinars. We are now preparing for the 2021 annual conference, which will be entirely online.

Our forecast was that as a result of these changes the APMAA 2021 conference would not receive as many submissions as in non-pandemic years. We altered the course of the annual conference towards "Quality is first. Return to the origin" as our policy for this year. We set up a slogan for APMAA 2021: "A Good quality conference, even if its size is small."

On May 15, we opened the manuscript submission site for the APMAA 2021 in the Conference Management Toolkit (CMT) system. Using CMT as the platform for the APMAA 2021 Conference, we invited around 40 volunteer reviewers who worked following our robust review guidance. By fully employing functions provided by the CMT, we provided feedback to help authors improve submitted manuscripts. Deeply committing to the APMAA 2021 mission, gatekeepers (acting as Paper Review Team Leaders) managed the whole review process by closely communicating with authors and reviewers. I believe the scheme enabled APMAA to build more value for its members. As the 2021 paper review team chair, I highly appreciate authors, reviewers,

and meta-reviewers who have spent massive time and energy making the APMAA 2021 Conference good quality.

Our association is an open network, and the goodwill of diligent volunteers has run the organization. Because of this, APMAA has always faced issues of sustainability. APMAA will celebrate the 20th Anniversary of its foundation in 2024. To thrive in the coming decade, we must focus on the renovation of the Administration Team and Regional Chapter system. We must build a more robust program that makes members feel good about the future.

Our journey to the 20th-anniversary conference has begun already.
