His main research areas are Carbon management Accounting, Sustainability Reporting, Corporate Sustainability, and Market Orientation. Dr Soheil, in addition to working as a PI or team member in several international scientific projects, has published many articles in high-indexed journals.

Dr. Khaled Hussainey is a Professor in Bangor University. He has over two & half decades of teaching and research experience at both undergraduate and postgraduate levels. He has published more than 250 articles in peerreviewed journals and experienced PhD supervisor with sixty PhD completions. She has published in journals including Managerial Auding Journal, Journal of Forensic and Investigative Accounting, and Research on Professional Responsibility and Ethics in Accounting.
